It features live music and street entertainers; activities for kids; special sales and events in Old Town businesses; displays from local non-profit organizations; and plenty of food, art, and retail vendors.

WEATHER POLICY: First Friday is a Rain or Shine event. Participation is at the discretion of the individual. In the event of severe weather and the First Fridays Committee determines that there is a threat to public safety the event may be modified or cancelled.

VENDOR FEE REFUND/TRANSFER POLICY: Vendor fees are non-refundable and cannot be transferred. The purpose of these fees is to cover the cost of promoting First Fridays in order to attract a large crowd and provide a good experience for all vendors and attendees.

COST: For profits: \$50/ea First Friday; \$250 for all six if paid in advance, in full. Nonprofits: \$35/ea First Friday; \$175 for all six if paid in advance, in full.
